- c. The supervised person's failure to initiate intake within 30 calendar days of notice of this order shall cause this order to be suspended pending further court hearing.
- d. The supervised person's failure to either maintain contact with the provider or to utilize supervised visitation or exchange for a period greater than _____ calendar days shall cause this order to become suspended pending further hearing.
- e. The provider shall be permitted access to the family law file of the above case for the sole purpose of obtaining information pertinent to scheduling appropriate visitation.
- f. A person's failure to comply with the provider's policies and procedures is a basis for the provider to suspend or terminate visitation or exchange services pending further court hearing.
- g. **If the provider makes a mandated report to Child Welfare Services, the provider shall promptly notify the court, the parties or their attorneys, and minor's counsel.**
- h. Dates and times of exchanges may be modified by MUTUAL AGREEMENT of the parties and with consent and availability of the provider.
- i. The provider shall provide the court, the litigants, and minor's counsel (if appointed) with a report of attendance, compliance with facility procedures, and/or assessment of supervised visitation/exchange. **The reports shall be submitted with a Declaration of Supervised Visitation Provider (Judicial Council form FL-324(P)).**
- j. Additional Orders:
 - (1) Any person transporting child(ren) by vehicle to and from visitations or exchanges must have a valid driver's license, car insurance, valid registration and appropriate safety restraints, including an age-appropriate car seat or booster seat as necessary.
 - (2) Gifts: Supervised person may bring gifts only per the provider's policy may NOT bring gifts.
 - (3) Food: Supervised person may bring food only per the provider's policy may NOT bring food.
 - (4) Photos: Supervised person may take photos or give the child photos only per the provider's policy may NOT take photos or give the child photos.
