# City of Vacaville (Findings 1, 2, 3, 4, 5) - RESPONSES

#### FINDING 1

Card usage saves time and money by not having to process purchase orders and wait for the arrival of ordered goods.

#### **RESPONSE TO FINDING 1**

City of Vacaville agrees with the finding.

#### **RECOMMENDATION 1**

Continue the use of cards.

## **RESPONSE TO RECOMMENDATION 1**

City of Vacaville will continue to use purchasing cards instead of purchase orders whenever it is beneficial.

#### FINDING 2

The use of cards has a transaction fee which is passed on to the consumer. On-time remittance of payment for card statements earn cash rebates with offset transaction fees.

## **RESPONSE TO FINDING 2**

City of Vacaville agrees with the finding.

#### **RECOMMENDATION 2**

All cities should seek to use financial institutions which offer cash rebates and pay all invoices on time to qualify for rebates.
