TO PUT A MATTER ON CALENDAR: All calendaring requests and most filing of motions and other documents should be made through the criminal clerk's office. COURTROOM RULES:

1. All electronic devices must be turned off and put away. Any devices making noise that disrupt the proceedings will be confiscated by the bailiff.
2. No shorts, tank tops, bare feet, sunglasses, or other unsuitable attire, and no chewing gum.
3. No food. Water is allowed only in re-closeable containers.
4. Anyone disrupting the proceedings will be removed from the courtroom.
5. Do not speak to any defendants who are in custody.
6. All attorneys and self-represented parties should check in with the bailiff upon arrival. All other parties, do not approach the judge, courtroom clerks, attorneys or bailiffs.
7. All witnesses, jurors and prospective jurors should wait in the hall until called in by the bailiff, unless instructed otherwise by court personnel.
8. Attorneys should not congregate in front of the jury box.

COURTROOM RULES:

1. All attorneys and self-represented parties should check in with the bailiff upon arrival.
2. All witnesses, jurors and prospective jurors should wait in the hall until called in by the bailiff, unless instructed otherwise by court personnel.
3. Cell phones and pagers must be silenced! Any devices making noise that disrupt the proceedings will be confiscated by the bailiff.
4. No shorts, tank tops, bare feet, or other unsuitable attire.
5. No food. Drinks are allowed only in re-closeable containers.
6. Anyone disrupting the proceedings will be removed from the courtroom.
7. Do not approach the judge or the courtroom clerks.
