# About Taking Transit

If you are able to take transit, the Fairfield Courthouse is served by FAST Route 1 from the Fairfield Transportation Center. Also, the Suisun/Fairfield Amtrak Train Station (177 Main Street, Suisun City, 94585) is less than a ten-minute walk to Fairfield Court locations.

The Vallejo Courthouse is served by SolTrans Route 4 from the Vallejo Transit Center in downtown Vallejo. Please see sample trip plans for reaching both courthouses. Call 1-800-535-6883 for up-to-date transit information.

## From Vallejo Transit Center to Solano Justice Building, Vallejo (SAMPLE)

**7:30 AM:** Depart Vallejo Transit Center on SolTrans #4 and arrive at Tuolumne & Carolina at 7:36 AM.

- Walk about 1 minute, 407 ft.
- Head south on Tuolumne St. toward Kissell Alley
- Turn right onto Kissell Alley

7:37 AM: Arrive at 321 Tuolumne St.

#### Option #1:

**4:35 PM:** Walk 3 min, 0.2 mi.

- Head east toward Tuolumne St.
- Turn left onto Tuolumne St.
- Turn right onto Florida St.

**4:38 PM:** Depart Florida St. & Tuolumne St. on SolTrans #7A and arrive at Vallejo Transit Center at 4:45 PM.

#### Option #2:

5:05 PM: Walk 2 min, 312 ft.

- Head east toward Tuolumne St.
- Turn left onto Tuolumne St.

**5:07 PM:** Depart Tuolumne St. & Capitol St. on SolTrans #4 and arrive at Vallejo Transit Center at 5:18 PM.

From Fairfield Transportation Center to Solano Justice Building, Fairfield (SAMPLE)

**7:30 AM:** Depart Fairfield Transportation Center on Solano Express Blue Line and arrive at Texas St. & State St. at 7:40 AM.

- Walk 6 minutes, 0.3 mi.
- Head west on Texas St.
- Turn left onto Union Ave.

7:46 AM: Arrive at the Solano Justice Building, Fairfield.

#### **RETURN TRIP**

- 4:39 PM: Walk 4 min, 0.2 mi.
- Head north on Union Ave.
- Turn right on Texas St.
- Turn left on Washington St. Destination will be on the right.

**4:43 PM:** Depart Armijo High School on FAST #1 **4:54 PM:** Arrive at the Fairfield Transportation Center.

## Solano County Superior Courts

The Superior Court of California, County of Solano is the unified trial court of both general and limited jurisdiction in the county. Comprised of 23 judicial officers (20 judges and 3 commissioners) with a staff of 196, the court has jurisdiction over all cases arising within the county. This includes felony and misdemeanor criminal cases, traffic, civil and small claims, family law, probate, and juvenile cases. The court operates four court facilities within the county including: The Hall of Justice at 600 Union Ave. in Fairfield, the Law and Justice Center at 530 Union Ave. Fairfield, the Old Solano Courthouse at 580 Texas Street in Fairfield, and the Solano Justice Building at 321 Tuolumne St., Vallejo.

## About Solano Mobility

In February 2014, the Solano Transportation Authority (STA) expanded their services to include the Solano Mobility Call Center. This was one of four Solano Mobility priorities identified in the Solano Transportation Study for Seniors and People with Disabilities, which was completed in 2011. As well as providing commuters and Solano County employers with information on a variety of transit services and incentive programs, the Solano Mobility Call Center provides seniors and people with disabilities with a range of mobility information.



# About The Pilot Program



The Equitable Access to Justice Pilot Program was started in June 2023 by the Solano County Superior Courts in partnership with the Solano Transportation Authority (STA) to help jurors, prospective jurors, specialty court participants, and collaborative court participants who do not have access to transportation or cannot afford transportation by providing them with fully funded transportation subsidies for court-related travel within Solano County. The goal is to eliminate transportation obstacles as a barrier to court participation. Please notify the court if you need transportation for your court appointment.

The courthouses are open from 8:00 AM - 5:00 PM. The Clerk's Offices are open by drop-in 8:00 AM - 11:30 AM or by appointment 8:00 AM - 3:00 PM. For more information on the Solano County Superior Courts, visit:

# For Jurors/Prospective Jurors



You can use the Equitable Access to Justice Pilot Program to travel roundtrip from your Solano County home to the Solano County Superior Court in Fairfield at 600 Union Avenue from Monday – Friday between 7 AM and 7 PM or the Solano County Superior Court in Vallejo at 321 Tuolumne Street from Monday – Friday between 7 AM and 7 PM.

All rides are 100% subsidized.

There are two options for receiving transportation:

- Court participants who have a smart phone and can use the Uber app will be issued a 100% subsidized Uber Voucher that will appear in the wallet of their Uber app.
- 2. Court participants who do not have a smart phone or who cannot use the Uber app will have a 100% subsidized Uber or Lyft ride provided for them.

Please notify the court if you need transportation and let them know which option will be best for you.
