Statutory Compensation: While the statutory calculation has now been provided, it appears to have a mathematical error. Court Staff calculate the fee as \$13,813.72 and not the amount stated. The values used were \$505,000 (Inventory and Appraisal), \$686.08

(Receipts), \$35,000 (Gains), \$0.00 (Losses) = \$540,686.08 as the basis for the calculation. This resulted in \$4,000 of the first \$100,000, \$3,000 of the next \$100,000 and \$6,813.72 of the remaining \$340,686.08 for a total of \$13,8713.72. The petitioner shall clarify.

If the petitioner resolves the issue by the hearing date, absent any objections the court intends to rule as follows:

The court finds all notices have been given as required by law. The petition is granted as prayed except that release of liability and discharge shall be ordered only upon the filing of the Ex Parte Petition for Final Discharge and Order once assets are distributed pursuant to Probate Code section 11753.
